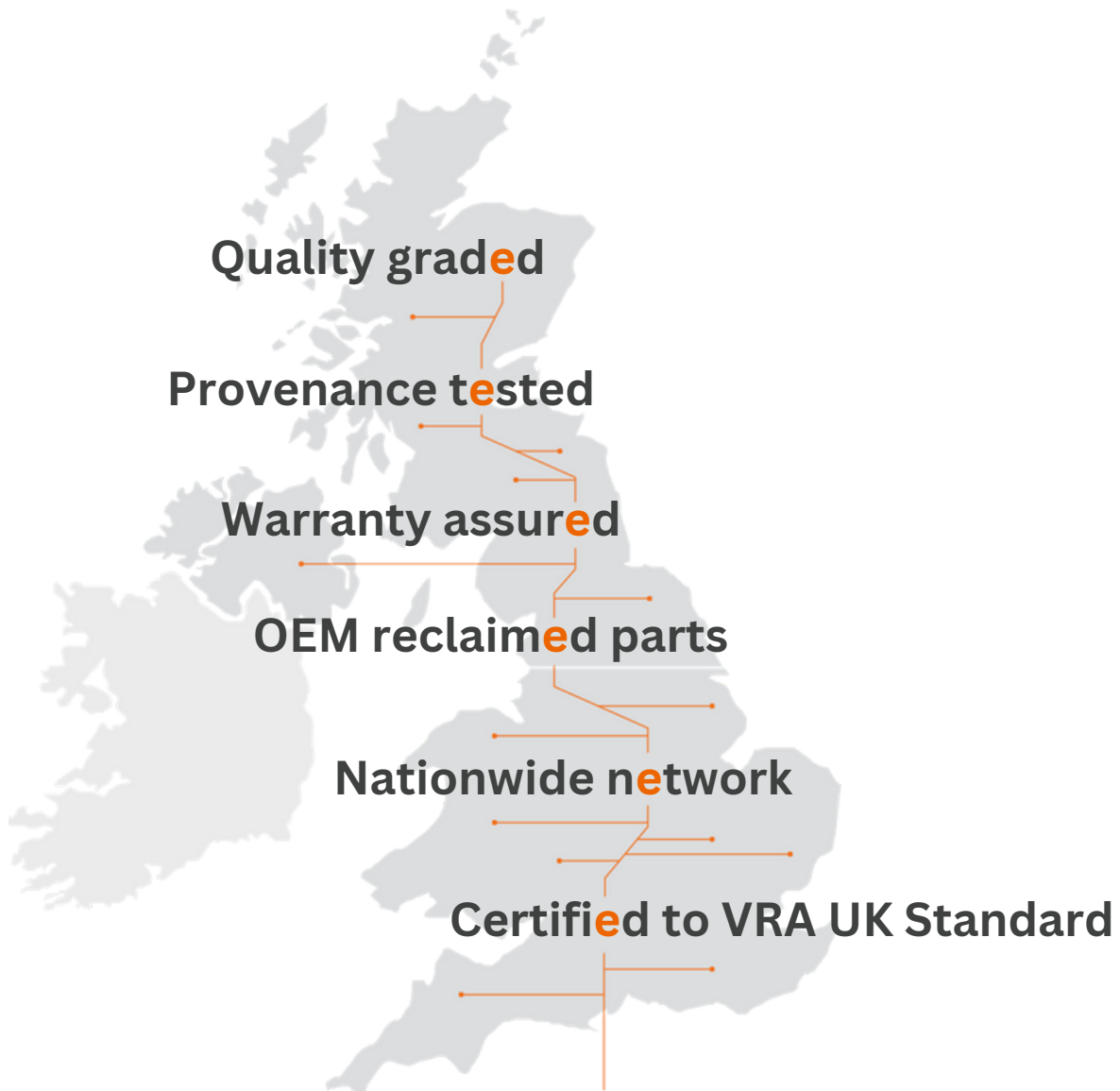

What is BS 10125?

British Standard 10125:2022 is the standard for “Automotive services – Specification for vehicle damage repair processes”. It was first published as a publicly available specification (PAS) 125 in October 2006 and became a full British Standard (BS 10125) in November 2014 with a minor update in September 2016. A further updated version became available on 9th November 2022 (BS 10125:2022)

It provides an up-to-date specification for vehicle damage repair processes that is in line with technological developments and currently recognised good practice.

Compliance by a bodyshop with the standard will ensure the safe repair of cars and vans under five tonnes. [It is not applicable to motorcycles, three-wheeled vehicles or vehicles over five tonnes gross vehicle weight.]

The standard ensures that bodyshops adhere to the ‘four Ms’:

1. **Man:** ensuring that personnel are fully trained and maintain required competencies
2. **Method:** ensuring that the bodyshop has demonstrable use of recognisable crash repair methods
3. **Machine:** ensuring that repairers have the correct equipment for the job – and that they are properly calibrated and employed
4. **Material:** ensuring that the correct parts and components are being used.

Approximately 1,000 UK bodyshops have been certified to BS 10125 standard from one of three certification bodies: BSI, CARS QA and RMISC.

Why is BS 10125 important?

For BS 10125 certified bodyshops, it is vital that when they are sourcing reclaimed vehicle parts, they can be confident that the reclaimed parts conform with the VRA standard. Thus, the VRAC certified vehicle recycler must ensure that the parts supplied to a BS 10125 bodyshop meet the requirements of the VRA standard.

What parts does BS 10125 specify?

BS 10125 specifies that replacement parts shall meet the following requirements:

- a) original parts for the vehicle to be repaired shall bear the vehicle manufacturer’s mark; or
- b) original parts for the vehicle to be repaired shall bear the part manufacturer’s mark; or
- c) parts for the vehicle to be repaired, shall be supported by certification (either self assessed by the parts supplier or independent third party validated) that the parts have been manufactured to the vehicle manufacturer’s speci-

fication and production standards for original parts; or d) parts for the vehicle to be repaired shall be supported by certification (either self assessed by the parts supplier or independent third party validated) that the parts are of quality and performance equivalent to the original parts.

NOTE 1 “Original parts” means parts or equipment which are manufactured according to the specifications and production standards provided by the vehicle manufacturer for the production of parts or equipment for the assembly of the vehicle in question. This includes parts or equipment which are manufactured on the same production line as these parts or equipment.

It is presumed, unless the contrary is proven, that parts constitute original parts if the part manufacturer certifies that the parts match the quality of the components used for the assembly of the vehicle in question and have been manufactured according to the specifications and production standards of the vehicle manufacturer.

NOTE 2 Reclaimed parts where provenance can be proved can be supplied under 3.5.1a), b), c) or d).

This means that non-original parts that have not been manufactured to the vehicle manufacturer’s specification and production standards for original parts, or that are not of equivalent quality and performance to the original parts are excluded from BS 10125.

Moreover, BS 10125 also requires that any non-original parts used by a repairer and specified in sections c and d need to be supported by certification which must be auditable and verifiable when the repairer is audited.

What is an Original Part?

This is a part or item of equipment that has been manufactured according to the specifications and production standards provided by the vehicle manufacturer for the production of parts or equipment for the assembly of the vehicle in question.

What does this mean?

As a vehicle recycler is unlikely to be able to confirm that any non-original part has been certified (and to provide auditable evidence of this), this therefore effectively excludes the supply of recycled non-original parts to bodyshops.

During parts grading it is therefore important that vehicle recyclers check that all target parts contain either a label or stamp with the vehicle manufacturer’s logo and/or part number to confirm that it is original. The VRAC parts grading course will be updated in due course to reflect this.

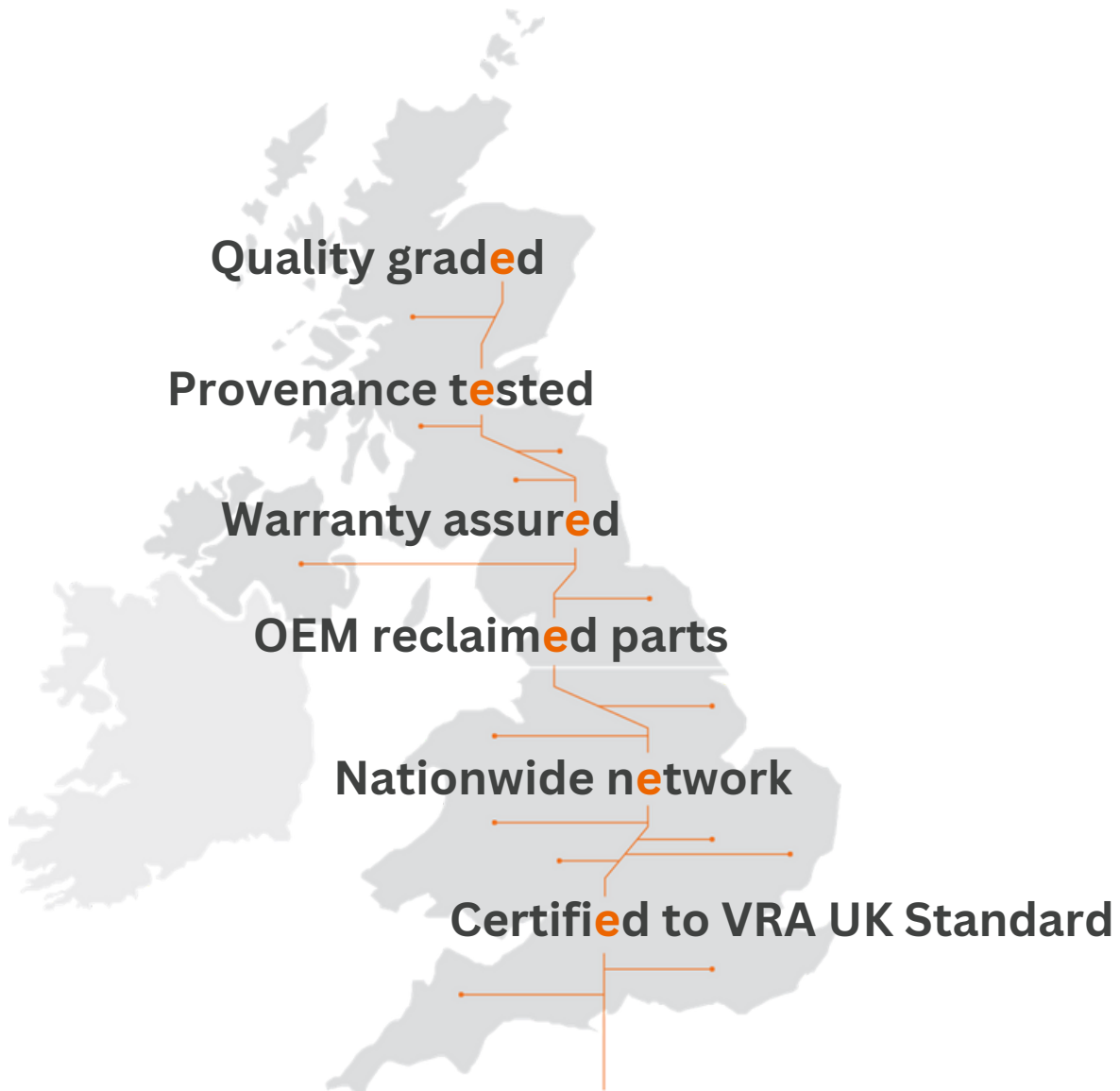
